ORDER:

In the Government Order first read above, orders were issued for re-employment from the academic year 1975-76 to the teaching staff working in Government Colleges, who attain the age of superannuation in the middle of an academic year, from the next day of superannuation upto 31st May of that year i.e., the last day of the academic year. The teaching staff retiring in the vacation period will not be eligible for re-employment.

In the Government Order second read above, powers have been delegated to the Director of Technical Education for sanctioning re-employment to teachers belonging to Technical Education department from the date of superannuation till the end of that Academic Year i.e 31st May of the year, subject to certain terms and conditions.

- 3. In the Government Order third read above, the Government have withdrawn the re-employment Scheme.
- 4. In the Government Order fourth read above, the Government restored the scheme of re-employment to the teaching staff working in the Government Engineering Colleges / Government Polytechnic Colleges and Special Institutions and Government Aided Engineering and Polytechnic Colleges.
- 5. In the Government Order fifth read above, general orders have been issued, allowing re-employment to Principals / Teachers including College Librarian, Physical Directors and Joint Directors working in Government / Government Aided Colleges, till the last day of the academic year i.e., 30th April, for those who are retiring on attaining the age of superannuation in the middle of the academic year, certain conditions and also delegating the power to Director of Collegiate Education for sanctioning of re-employment to college teachers upto Principal Grade-II, including Director of Physical Education and Librarians from the date of superannuation, till the last day of the academic year i.e. 30th April of the year and to send the proposals for re-employment of Principal Grade-I / Regional Joint Directors of Collegiate Education / Joint Directors of Collegiate Education to the Government as per the procedure in existence.
 - 6. In the Government Order sixth read above, orders have been issued as follows: -
 - (a) dispensing with re-employment of Joint Directors, Regional Joint Directors, Principals Grade I, Principals Grade II, College Librarians and Physical Directors, who are engaged in administrative nature of job and to allow them to retire on the last day of the month during which they attain the age of superannuation;

and

- (b) allowing re-employment only to Teaching staff, who are really involved in imparting quality education to the students, who attain the age of superannuation during the middle of the academic year, till the close of the academic year i.e. 31st of May, subject to the following conditions:-
 - nothing adverse has been reported against the faculty.
 - the faculty has made exemplary contribution in imparting education to the student community.
 - iii. the re-employment shall be decided by the Director of Collegiate Education based on the recommendations of the respective Principals.
 - iv. During the period of re-employment, they shall draw such pay as together with their pension and pension equivalent to Death-Cum-Retirement Gratuity and the amount shall not exceed the pay last drawn by them at the time of their retirement, vide Rule 44 of Tamil Nadu Pension Rules, 1978.

- v. Any amount of over payment pertaining to the pre-retirement period shall be recovered, by adjustment of the pay and allowances, admissible to them, during the period of re-employment.
- vi. Their behaviour and conduct of work should continue to be satisfactory.
- vil. Disciplinary / Criminal / Directorate of Vigilance and Anti-Corruption cases shall not have been contemplated or pending against the re-employed officer.
- viii. Their heath condition should be normal.
- ix. Their service shall be liable for termination at one month's notice, on either side, within the specified terms. Provided that it shall not be necessary for the authority which sanctioned the re-employment to give the notice of one month referred to above, to the re-employed officer, if the services are terminated on the ground of moral turpitude.
- 7. The Government after careful examination, have directed to
 - a) dispense the re-employment of Principals, Librarians and Physical Directors working in Government Engineering Colleges / Government Polytechnic Colleges and Special Institutions and Government Aided Engineering and Polytechnic Colleges, and Additional Director of Technical Education (Polytechnics) / Additional Director of Technical Education (Exam) / Teaching Staff working in administrative posts at Directorate of Technical Education and to allow them to retire on the last day of the month during which they attain the age of superannuation;

and

- b) to allow re-employment only to Teaching staff, who are really involved in imparting quality education to the students, who attain the age of superannuation during the middle of the academic year, till the close of the academic year i.e. 31st of May, subject to the following conditions: -
 - nothing adverse has been reported against the faculty;
 - ii. the faculty has made exemplary contribution in imparting education to the student community;
 - iii. the re-employment shall be decided by the Commissioner of Technical Education based on the recommendations of the respective Principals.
 - iv. During the period of re-employment, they shall draw such pay as together with their pension and pension equivalent to Death-Cum-Retirement Gratuity and the amount shall not exceed the pay last drawn by them at the time of their retirement, vide Rule 44 of Tamil Nadu Pension Rules, 1978.

- v. Any amount of over payment pertaining to the pre-retirement period shall be recovered, by adjustment of the pay and allowances, admissible to them, during the period of re-employment.
- vi. Their behaviour and conduct of work should continue to be satisfactory.
- vii. Disciplinary / Criminal / Directorate of Vigilance and Anti-Corruption cases shall not have been contemplated or pending against the re-employed officer.
- viii. Their heath condition should be normal.
- Their service shall be liable for termination at one month's notice, on either side, within the specified terms. Provided that it shall not be necessary for the authority which sanctioned the re-employment to give the notice of one month referred to above, to the re-employed officer, if the services are terminated on the ground of moral turpitude.
